

LEAF COMPOST AND TAN BARK

Due to liability concerns the Township staff will no longer be permitted to load the leaf compost or tanbark for the resident. Both items are still available for self loading, free-of-charge, at the Yard Waste Facility. The Yard Waste Facility is open 7 a.m. to 12 p.m. on the 1st and 3rd Saturday of each month thru October 16, 2010.

Residents who want to take advantage of our new delivery service must complete an Order Form and Release Agreement and make payment at the Municipal Building. The charge for delivery of tanbark or leaf compost is \$50. Orders will be accepted Monday thru Thursday of each week, with a Friday delivery. If the Friday falls on a Township holiday delivery will take place on Thursday of that week. The delivery service will be scheduled on a first come first serve basis with a total of ten (10) orders per week. The product will only be placed on the driveway of the property. I/WE ALSO AGREE TO INDEMNIFY AND DEFEND EAST PENNSBORO TOWNSHIP, ITS EMPLOYEES, COMMISSIONERS AND/OR AGENTS FROM ANY CLAIMS AND LIABILITY RELATING TO PERSONAL INJURY AND PROPERTY DAMAGE IN ANY WAY ASSOCIATED WITH THE DELIVERY AND/OR PLACEMENT OF LEAF COMPOST OR TANBARK ON MY/OUR PROPERTY, REGARDLESS OF ANY NEGLIGENCE ON THE PART OF EAST PENNSBORO TOWNSHIP, ITS EMPLOYEES OR AGENTS.

I/we acknowledge that I/we are able, at my/our expense, to pick up and deliver leaf compost and tanbark to my/our property; however, I/we voluntarily desire East Pennsboro Township to deliver leaf compost or tanbark for an established fee, subject to the terms of this Release and Agreement.
