ACCESS CARD APPLICATION – COMMERCIAL BUSINESS

The primary purpose of this facility is to provide a drop off location for the disposal of leaves, brush and shrubbery clippings which are then turned into mulch and compost.

**Anyone found in violation of the following rules may have their privileges revoked, without refund and shall be subject to applicable fines and/or penalties as the law allows.**

ACCESS CARDS are available for the following user classifications:

- Residents located within East Pennsboro Township (\$10.00 per year)
- Commercial landscaping/tree business located within East Pennsboro Township (\$800.00 per year)
- Commercial landscaping/tree business located OUTSIDE East Pennsboro Township (\$1200.00 per year)

One access card per household.

Do not leave empty bags or containers at the facility.

The use of skid loaders and chainsaws is strictly prohibited at the Yard Waste Facility.

Rates and rules are established on an annual basis and may change at the discretion of the Township.

Residents may be denied an access card due to high outstanding balances on their sewer/sanitation accounts.

Use of the Yard Waste Facility is AT YOUR OWN RISK; please use caution when entering and exiting the facility.

Yard Waste Facility is open for access card holders from March 1<sup>st</sup> through December 31<sup>st</sup>, cards must be renewed each year.

**The following items are strictly prohibited:**

Branches and/or tree stumps in excess of fourteen inches (14") in diameter • grass clippings • garbage • dirt • stones • fruits and vegetables • trash • hazardous waste • medical waste • appliances • tires • scrap metal • treated lumber • landscaping timber • painted wood • furniture • commercially chipped wood • construction and/or demolition debris.
